

EXECUTIVE COMMITTEE MEETING

The Executive Committee meeting was held October 5, 1968, in Ottawa, with only one member unable to attend. President J.C. Ritchie presided and many business items were transacted. Some of the items discussed and not included elsewhere in the *Bulletin* are the following.

Constitution: The mail ballot indicated 112 in favor to 1 against adoption of the revision. The negative vote was accompanied by a letter which has been passed to the Constitution Committee (F.L. Staplin, Chairman).

Dues: The dues for 1969 were set for regular members at \$6 to include the Biological Council of Canada fee. Any member paying this \$1 through another organization is exempt from this assessment. Dues for student members are still \$2.

Membership: There are 368 regular members and 81 student members. This includes 13 new members who have joined subsequent to June, 1968.

Nominating Committee: Past President R.L. Taylor was appointed as Chairman. Also appointed are M.M. Grandtner of Université Laval, and Taylor A. Steeves of University of Saskatchewan.

Canadian Journal of Botany: Only one member responded to the request for comments on the Journal. The Executive Committee will recommend that if only one style of reprints is to be available that it be without covers and stapled by the hinge method, if possible. Also it will be recommended that N.R.C. adopt a policy of publishing supplements which will be used for large monographs or symposia on Canadian material. A further recommendation made by the Executive Committee includes publication of abstracts in both French and English. The translations to be provided automatically by the N.R.C. Editorial Office. Finally, it was suggested that the Journal indicate in its regulations for publication that an author using colour plates will have to bear the total cost for all copies of the Journal (ca. 2500) as well as reprints.

Future Meetings: The 1969 meeting will be at the XI International Botanical Congress. The 1970 meeting has been scheduled for Dalhousie University with the Canadian Society of Plant Physiologists and the Canadian Phytopathological Society. However, Dalhousie may not conveniently host the meeting so that other arrangements could become necessary. The University of Alberta has offered to host the 1971 meetings. These will probably be in conjunction with the Botanical Society of America who have expressed an interest. Also the Alaska Section of the American Association for the Advancement of Science will be asked if they are interested in participating.

Biological Council of Canada: CBA-ABC were represented by Drs. Ritchie and Taylor at the October meeting. They were asked to communicate the

XI INTERNATIONAL BOTANICAL CONGRESS

The dates for the Congress are August 24 to September 2, 1969, in Seattle, Washington. The sessions on nomenclature will begin on August 21. The Second Circular has been mailed to those who returned the pre-registration form from the First Circular. The CBA-ABC plans to hold an evening dinner meeting that will include a short business meeting. The evening will be relaxed and will feature a guest speaker. At this time the first awards of CBA-ABC will be presented and the new officers will be named. Several of the field trips scheduled in conjunction with the Congress will include parts of western Canada and involve several members of the Association.

Association's view that there should not be total uniformity in biology teaching in high schools and universities. Also see "Botanists and Government Policy".

Directory of Canadian Botanists: Drs. R.J. Moore and J.H. Soper are compiling the Directory of Canadian Botanists. Those who did not return the information form will be listed without any details as to interests and area of research.

Botanists and Government Policy: President Ritchie discussed CBA-ABC's role in affecting national policy through the Biological Council of Canada, the Science Council, and the Science Secretariat. He put forward the view that ecological and systematics research are not receiving the support and that the BCC survey (compiled by Dr. K.C. Fisher) will emphasize this. At present there are few resources and little money available for field research. The Executive Committee agreed that the CBA-ABC delegates to the Biological Council of Canada must play a most significant role in the developing of government concepts with regard to basic biological research.

Commission on Relations between Universities and Governments: The Secretary was asked to communicate that the membership of CBA-ABC bridges the terms of reference of the Commission. However, CBA-ABC has a potential consulting capacity as it is interested in people and botany and the environment.

Further items covered at the Executive Committee meeting are discussed separately in this issue of the CBA-ABC Bulletin.

RESOLUTION AND RESPONSE

At the annual meeting in June, 1968, the resolution concerning the exploration of the Canadian Arctic Archipelago by resource industries was approved as follows:

The CBA-ABC recommend to the Minister of the Department of Indian Affairs and Northern Development that the companies concerned should be instructed to seek the advice of CBA-ABC regarding ecological considerations before any exploration or construction be made; or if operations have already begun that CBA-ABC be informed so that an evaluation of the disturbance could be undertaken with the assistance of the companies involved."

The Resolution was forwarded to the Resource and Economic Development Group and to the Canadian Wildlife Service (both part of the Department of Indian Affairs and Northern Development). Replies were received from both branches and they are quoted, in part, herein.

John S. Tener, Deputy Director, Canadian Wildlife Service: "The resolution will be passed on to senior departmental officials for their consideration but I must say that it is unlikely that the department would agree with it to the extent that companies undertaking mineral exploration in the north would be required to consult with your organization first.

"We are particularly conscious of the necessity for controlling and preventing as far as possible damage to the Arctic and sub-Arctic environments by those engaged in mineral exploration activities. A number of departmental safeguards have already been placed to ensure that damage is confined and this Branch is in process of defining more explicitly the kind of regulations we would like to see applied. We have already had many contacts with oil exploration companies in particular and have given them our view and expressed our concern about the necessity of preserving as intact as possible the fragile environments of the north. The companies have been very cooperative to date and we are hopeful that given their continued good co-operation within a framework of an effective set of regulations, adequate safeguards will be exercised."

A.T. Jordan, Acting Chief, Oil and Mineral Division, Resource and Economic Development Group: "For many years, our Department has been cognizant that extensive resource exploitation or construction of air-strips and base camps can produce long-lasting deleterious effects on the landscape, flora and fauna of our Arctic. We are therefore in constant communication with officers of the Canadian Wildlife Service regarding the preservation of our northern environment. As an example, every operator or resource company that plans to conduct work in the Arctic regions or on the northern mainland is issued with a "Letter of Instruction". Every seismic and drilling operation is under surveillance by our Oil Conservation Engineer to prevent damage to the surface environment, and game officers of each Territory are notified when exploratory operations are commenced in their areas. As an added precaution, the Canadian Wildlife Service monitors every operation and makes periodical inspections on the ground to investigate such operations that can cause damage to the landscape.

"In the opinion of our conservation officers, the operations are constantly under surveillance and remedial action is taken if any damage is discovered."

NEW JOURNAL

To commemorate the opening of its new building in 1968, the British Columbia Provincial Museum will publish a new technical journal called Syesis. The journal will be restricted to studies dealing with the Pacific Northwest, with preference given to those concerned primarily with or related to the British Columbia environment. It will be of a technical nature directed toward professionals in the various areas of natural and human history. In the area of natural history (animal, earth, and plant sciences), papers should deal primarily with regional studies of a descriptive nature, such as ecology, morphology, taxonomy, and systematics; and in the area of human history, papers should deal primarily with studies in archaeology, ethnology, history, linguistics, and sociology. Long or monographic papers, as well as short papers, may be accepted, and short notes on brief matters such as range extensions of fauna and flora and other new discoveries of professional interest may be included.

Following the commemorative edition, which will appear early in 1969, the journal is planned as a biannual publication with the possibility of increasing to a quarterly. The first issue will be widely distributed without charge. Subsequently the journal will be distributed on an exchange basis. It will also be available to institutions and individuals on a subscription basis.

Syesis means "a story about an actual event" and is used often in the sense of "one's history". It is a noun taken from the Sooke Indian dialect of the Straits Coast Salish. This dialect was originally spoken in the region of Sooke at the southern end of Vancouver Island but the few remaining speakers are now scattered.

ALBERTA INFORMATION RETRIEVAL ASSOCIATION

This Association was organized to provide a number of services related to the handling and searching of Technical information. Originally founded in 1967 as the Alberta Experimental SDI Association it was composed of universities and other organisations to provide staff members with experience in computer searching of technical literature. The group was one of 24 participants (and the only group participant of its kind) in 'An Experiment in Selective Dissemination of Information', organized by Chemical Abstracts Service of the American Chemical Society.

The Association at present provides three services: 1-computer search of current chemical titles; 2-ASCA and citation searches through an arrangement with the Institute for Scientific Information; 3-custom literature searches.

ABC-CBA AWARDS

Plans call for presenting the first awards in 1969 at the Annual Meeting to be held during the XI International Botanical Congress. The awards, which were approved at the 1968 meeting, will consist of silver medals with green and gold ribbons.

The terms of reference for the awards were approved by the Executive Committee at the October meeting. The purpose is, "To provide a collective, formal expression of the admiration and respect of botanists in Canada for the excellence of the contribution of an individual to Canadian botany." Two awards can be given annually. One award may be for a single outstanding contribution to botanical knowledge. A second award may be given in recognition of cumulative distinguished contributions of a senior investigator, teacher, or administrator. It is possible that only one award or none will be given. Any professional botanist working permanently in Canada is eligible as it is hoped the establishment of the award will foster botanical excellence in Canada.

The Selection Committee for 1969 (named by the Executive Committee) consists of the Association President (J.C. Ritchie), the Past President (R.L. Taylor), 3 Association members (P.R. Gorham, W.B. Kendrick, J.S. Rowe), and a senior scientist from a related discipline (Dean D.M. Ross, University of Alberta). Nominations for the awards should be received by January 15, 1969. To nominate, send the name and a concise statement of the meritorious contribution(s) to President Ritchie at Dalhousie University. Further details concerning the candidates will be solicited later. The more botanists suggested for the awards, the more significant the awards will be. Further information concerning the awards can be secured from any member of the Executive or the Awards Committees.
