

# GARDEN MEMBERSHIP CLOSES OUT 1987 WITH RECORD NUMBERS

The Missouri Botanical Garden closed out 1987 with a record-setting 20,778 members, an increase of 12.3 percent over 1986's total of 18,490. The Garden's membership is the largest of any St. Louis cultural institution, and the largest metropolitan membership for botanical gardens worldwide.

"While membership here at the Garden has increased steadily over the last three years -- 35.8 percent -- 1987 numbers are particularly healthy with an increase of 2288 new members," said Dana Hines, membership marketing coordinator for the Garden. "One of the reasons it increased so much last year is due to the creation of a junior membership category, the MoBot Club." Since its inception in July, the MoBot Club has enlisted 527 members of all ages. The club is fun-oriented and features a wide variety of activities designed especially for children and their families. Its goal is to help establish the value of belonging to and supporting cultural institutions at an early age.

Regular Garden membership is \$35, and entitles supporters to free admission to Garden grounds, Tower Grove House and Shaw Arboretum. In addition, supporters receive a member's magazine, are invited to exclusive "members-only" events, and receive discounts on educational courses and on gifts and plants in the Garden Gate Shop.

THE UNIVERSITY OF BRITISH COLUMBIA BOTANICAL GARDEN HAS A NEW DIRECTOR

Mr. A. Bruce Macdonald has been appointed Director of the University of British Columbia Botanical Garden. He was formerly Assistant Director when Dr. Roy Taylor was Director and later Acting Director when Roy moved to Chicago Botanic Garden in 1985.

The University of British Columbia Botanical Garden has been given a recent donation of \$1 million by a private donor, Mr. David Lam. The money is to be used toward a new office-research building in the Botanical Garden.

#### BOOK REVIEWS

Ireland, R.R., 1982, Moss Flora of the Maritime Provinces. National Museums of Canada, Publications in Botany, No. 13. 738 pp. including 415 plates (\$25.00).

It is a major event when a floristic manual is published in Canada. The appearance of Dr. Ireland's elegant flora is of particular importance because it is the first comprehensive manual of mosses for any part of Canada. Dr. Ireland is eminently qualified to produce such a work. His research is meticulous and concise, based on an extensive knowledge of mosses as living plants in the field. He is especially fortunate in his illustrators Linda Ley, Anne Hanes and Gilda Bellio-Trucco. The beauty of the habit sketches and the well-chosen details of structure substitute for detailed descriptions of each species. Each plate represents many hours of painstaking labour, not least of which is the careful choice of the most representative material for illustration.

The maritime provinces of Canada have been utilized for agriculture and forestry since the sixteenth century, thus few sites remain that have not been disturbed by man's activities. This means that many bryophytes are now found in very few localities. A number of species, for example, have not been collected since the nineteenth century (Tortula ruralis, Grimmia anodon, Desmatodon heimii, Kiaeria starkei, Entodon brevisetus, Meesia uliginosa,

Splachuum luteum. Thuidium minutulum. T. scitum). This may represent extinctions or may simply reflect rarity in the Maritimes. It is a monument to Dr. Ireland's careful field and herbarium research that he has attained a reasonably complete census of the moss flora. His book should stimulate students and amateurs to make further contributions to the flora of these provinces.

Dr. Ireland's researches coincided with those of H. A. Crum and L. E. Anderson, whose Mosses of Eastern North America appeared a year earlier. Thus Dr. Ireland's observations are original rather than derivative. This vastly increases the strength of his volume that complements the volumes of Crum and Anderson.

The moss flora of Nova Scotia, in particular received the attention of two gifted amateurs, M. S. Brown and J. S. Erskine. Their many collections from all parts of the province have been not easily accessible for many years. In consequence, Dr. Ireland was unable to verify some reports based on these collections. Recently, however, Acadia University has curated these collections and made them available for study. Thus it is possible to verify the presence of Bruchia sullivantii Aust., and Micromitrium austinii Aust. from Nova Scotia and to note that among the excluded taxa mentioned by Ireland (pp. 694-700) Campylium halleri (Hedw.) Lindb. from Nova Scotia is Herzogiella. Hypnum vacheri Lesq. from Nova Scotia is H. cupressiforme Hedw., and Meesia longuiseta from Nova Scotia is Scotia is Dicranella polustris (Dicks.) Crundw. Warb. Dr. Ireland's book reinforces the that such collections are of eternal importance, and that their conservation should not be hampered by money-absorbing schemes of molecular biology.

## BOOK REVIEWS

Duncan, Betty D. & Golda Isaac, 1986.\_\_Ferns and Allied Plants of Victoria, Tasmania and South Australia. xii + 258 pages. Melbourne University Press (available in North America from I.S.B.S. Inc., 5602 NE Hassalo St., Portland, Oregon 97213 (\$20.00 (U.S.) + 2.25 shipping).

This is a beautiful book, first made apparent from the handsome cover painting by Celia Rosser, a botanical artist of great talent. Further evidence is in the 49 beautiful colour photographs. Black-and-white photographs and line drawings are also included for critical details and distribution maps

show the local distribution of many species.

In the region there are 130 species representing 53 genera. This is slightly more than one-third of the "pteridophyte" flora of Australia.

Introductory chapters give basic information on structural and biological details important in an understanding of the plants. A tabular key plus an illustrated dichotomous key guide the reader to the determination of genera, while each genus has a key to all local species. The keys are simple and appear to be constructed with the amateur in mind, with a minimum of terminology and a maximum of clarity. The species are arranged in each genus in the sequence that they key out.

Generic and species descriptions are ample and information detailing habitat and other biological features plus the derivation of the name are useful to the fern enthusiast. These reflect a keen acquaintance with the living plants in the field.

A chapter on propagation and cultivation is provided by D. J. Goudy and R. J. Hill. This is well illustrated and encourages gardeners to propagate these plants from spores rather than transplantation from nature; regrettably they were unable to supply methods of growing the notoriously difficult to propagate genera Gleichenia. Tmesipteris and Schizaea.

An extensive bibliography, index to authors of plant names and a comprehensive index to the text are included.

A few minor criticisms can be directed at some of the black-and-white photographs that are either too dark or too light, and to several of the line-drawings that appear to be rather hasty sketches. Under <u>Isoletes</u> a key is presented for only two of the six species mentioned. Scanning electron micrographs of mega- and micro-spores would have been extremely useful for this genus. <u>Ophioglossum</u> has no key for species, yet three species are noted to be present in the area.

Anyone interested in ferns will find the book a valuable addition to the library; those who teach a course where ferns are treated will find the book useful.
